

Web Site Terms and Conditions

A. Acceptance. Use of the Limoso ("Limoso") web site at www.limoso.com.au and www.designyourlimo.com.au (collectively, the "Web Site") and the on-line reservation services (the "Services") provided by Limoso are subject to the terms and conditions of use set forth below ("Terms of Use"), which include the Privacy Policy set forth in our www.limoso.com.au/policy and incorporated into these Terms of Use by reference.

PLEASE READ THESE TERMS OF USE CAREFULLY BEFORE USING THE WEB SITE OR THE SERVICES. BY USING THE WEB SITE OR THE SERVICES, YOU AGREE TO THESE TERMS OF USE. IF AN INDIVIDUAL IS USING THE WEB SITE ON BEHALF OF A BUSINESS ENTITY, WHETHER AS AN EMPLOYEE, CONSULTANT OR AGENT OF SUCH BUSINESS ENTITY, BY DOING SO, SUCH INDIVIDUAL REPRESENTS THAT THEY HAVE THE LEGAL CAPACITY AND AUTHORITY TO BIND SUCH BUSINESS ENTITY TO THE TERMS OF USE. L. Waivers and Remedies. The failure of Limoso to partially or fully exercise any rights or the waiver of Limoso of any breach of these Terms of Use by you, shall not prevent a subsequent exercise of such right by Limoso or be deemed a waiver by Limoso of any subsequent breach by you of the same or any other term of these Terms of Use. The rights and remedies of Limoso under these Terms of Use and any other applicable agreement between you and Limoso shall be cumulative, and the exercise of any such right or remedy shall not limit Limoso's right to exercise any other right or remedy.

M. Access. This Web Site and Service is provided from Australia and all servers that make it available reside in the Australia. The laws of other countries may differ regarding the access and use of the Web Site and Service. We make no representations regarding the legality of this Web Site and Service in any other country and it is your responsibility to ensure that your use complies with all applicable laws outside of Australia.

N. Arbitration. Any and all disputes pursuant to these Terms of Use, or otherwise between the parties, shall be submitted to binding arbitration in the state of Queensland, Australia in accordance with the commercial law then in effect. The arbitration panel shall consist of one (1) neutral arbitrator if the amount in controversy is less than \$25,000.00 AU, otherwise the panel shall consist of three (3) neutral arbitrators. The costs of the arbitration shall be shared equally by the parties, provided that, the arbitrator/s may award legal costs and expenses to the prevailing party. The parties agree that any actions or disputes shall be adjudicated between the parties hereto, and shall not be combined with any other actions or disputes of other parties. Notwithstanding the foregoing, this arbitration clause shall not in any way be deemed to limit Limoso rights to commence an action in an appropriate

court (and without submitting to arbitration) to protect its intellectual property rights or command prohibited use of the Web Site and Service.

O. Prevailing Law. The laws of the state of Queensland, Australia shall govern these Terms of Use. Subject to the arbitration provision above, YOU HEREBY EXPRESSLY CONSENT TO EXCLUSIVE JURISDICTION AND VENUE IN THE COURTS LOCATED IN BRISBANE, QUEENSLAND, AUSTRALIA FOR ALL MATTERS ARISING IN CONNECTION WITH THESE TERMS OF USE OR YOUR ACCESS OR USE OF THE WEB SITE OR SERVICE.

P. Force Majeure. Limoso shall not be responsible for damages caused by delay or failure to perform, in full or in part, any of its obligations in connection with the Web Site or Services, provided that there is due diligence in attempted performance under the circumstances and that such delay or failure is due to fire, earthquake, unusually severe weather, strikes, government sanctioned embargo, flood, act of God, act of war or terrorism, act of any public authority or sovereign government, civil disorder, delay or destruction caused by public carrier, or any other circumstance substantially beyond the control of Limoso.
